



Terms & Conditions

Admission Fee: \$5 per 30-minute session OR spend a min. of \$50 (max. 2 same-day combined receipts) in Capitol Singapore and/or CHIJMES. Perennial Online members, DBS/POSB Cardholders, and The Capitol Kempinski Hotel Guests are only required to pay \$4 per 30-minute session OR spend \$40 (max. 2 same-day combined receipts in Capitol Singapore and/or CHIJMES).

* Admission fee is not inclusive of the renting of skating shoes, skating aids, helmet, knee/elbow guards, and socks. All guests entering the Skating Rink are required to wear skates and socks.

- Limited to **one (1)** redemption per shopper, per transaction, per day, on a first-come, first-served basis, subject to availability and while stocks last.
- Maximum **two (2)** accumulated same-day receipt(s) at any outlet in Capitol Singapore and/or CHIJMES.

- The “Skating Rink” is open to all with a min. age of 10 years old and above from 5pm to 9pm daily. (Last entry at 8:30pm)
- One accompanying adult is to be present onsite at all times to supervise their child.
- All participants will be required to sign an indemnity form before participants enter the “Skating Rink” and must adhere to all rules and regulations.
- Play slots are available on a first-come, first-served basis, subject to availability and while stocks last.
- Duration for each play slot is for 30 mins and participants are required to reach 10 mins before each scheduled play slot.
- For pre-booked play slots, entry will be forfeited if the registered participant is not present within 5 mins after commencement of the booked play slot.
- No footwear allowed in the “Skating Rink”. Wearing of skates and socks are required.
- For health and safety reasons, participant running a temperature above 37.5-degree Celsius or is unwell will not be permitted entry in the “Skating Rink”.
- No food and drinks are allowed in the “Skating Rink”.
- No pushing or rough play allowed in the “Skating Rink”.
- Children should be toilet-trained to be allowed entry into the “Skating Rink”.
- For safety reason, the play slot may be cancelled at the discretion of The Management in the event of wet weather.
- Tickets are non-refundable and non-exchangeable under any circumstances.
- All footwear, accessories, valuables and loose items including, but not restricted to handphones, cameras, jewellery and any electronic devices must be removed before entering the “Skating Rink”. Any valuables brought inside the “Skating Rink” will be at owner’s discretion.
- The Management will not be responsible for any loss, damage or injury sustained by the ticket holder while in any of the activities in Capitol Singapore and CHIJMES. The Management may provide assistance; however such act is not an admission of liability.
